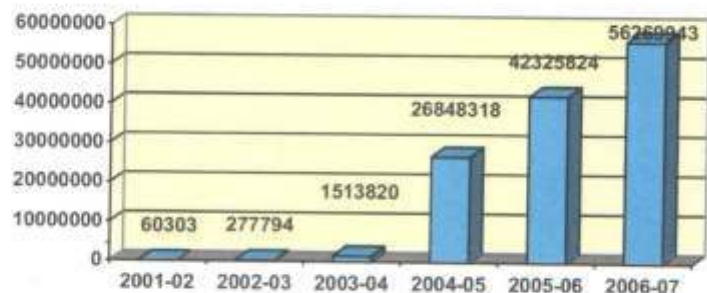

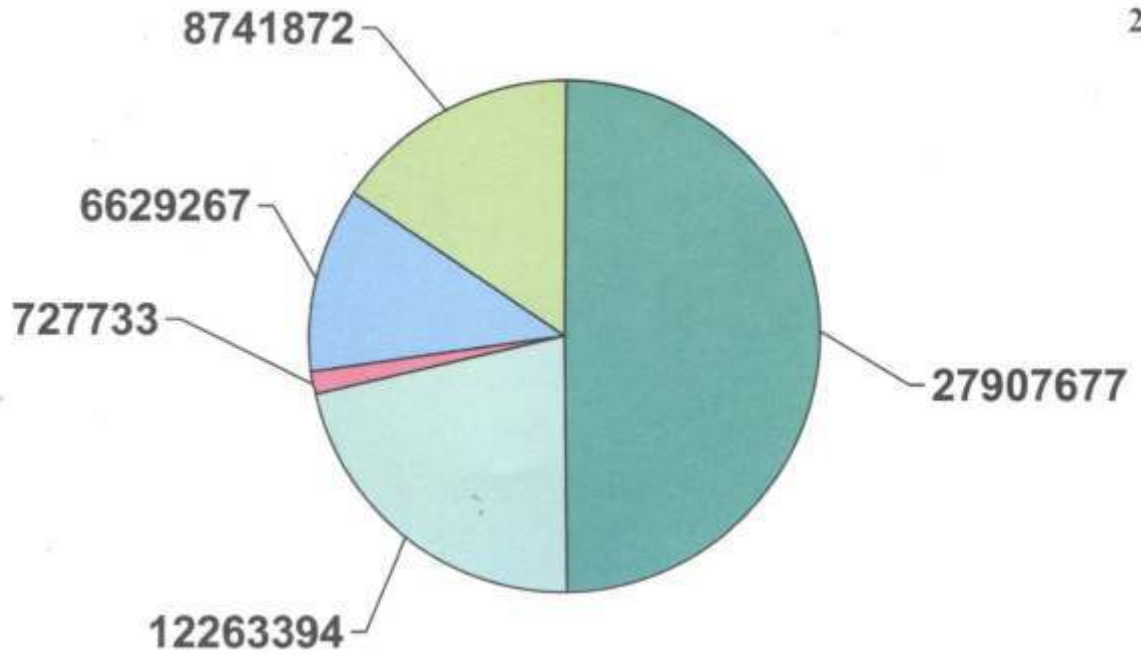

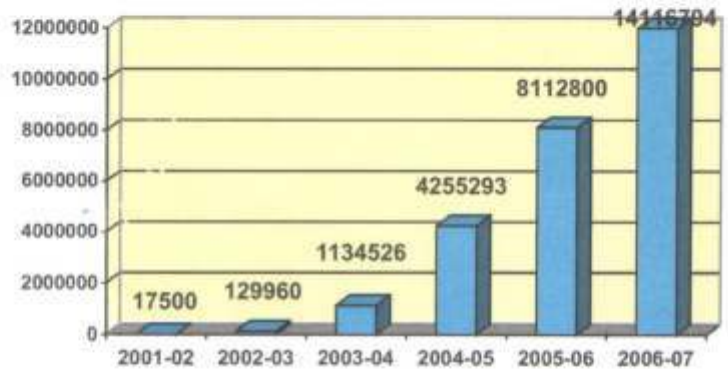
BREAKUP OF TOTAL COLLECTION 2006-2007.

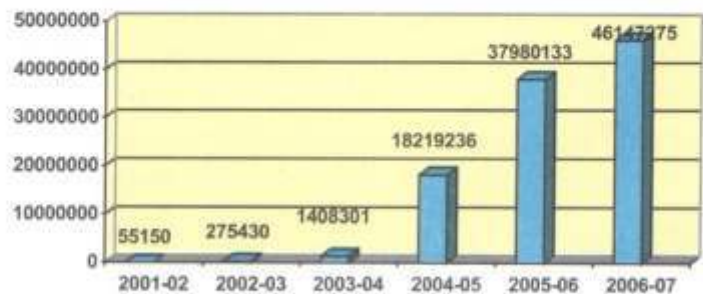
3. **Medical help to poor cancer patients:-** The following table will give you a birds eyeview of help provided to poor cancer patients during the last six years.

6. **Collections:-**

I) **Schools & Colleges:-** I am pleased to inform you that our Resource Mobilisation Department has collected record donation of Rs.3,68,000/- approx from The Dadar Parsee Youths Assembly High School, Dadar (E), Mumbai through the donation cards scheme. This is the highest collection ever from any single school and this gesture from their end has been appreciated by presenting Mementos & Certificates to the school and students respectively. Last year we have collected Rs. 8,56,445/- from schools and colleges. This collection was made by the students of various schools and colleges.

Kazi, Secretary General, who has done his PhD in Head & Neck Cancer at the Royal Marsden Hospital, London, U.K. has been awarded 'Byers Award' by the Expert committee of the American Head & Neck Society for year 2006. Earlier recipients of this award have been Europeans. He is therefore, the first Indian to get this American Award for his paper in Head & Neck Cancer. He has been invited to give oral presentation of his paper at the Annual Meeting of the American Head & Neck Society to be held in Chicago, U.S.A. from 17th August 2006 to 22nd August 2006. In this conference the Byers Award for 2006 – Citation and Cash – was presented to him.
10. **Cancer Patients-Donors Get-Together:-** On 4th May, 2006 we celebrated Cancer Patients-Donor Get-Together with a view to enable the donors and cancer patients to interact with each other and know about the well being of the patients and utilization of the donated fund. 19. **Yet Another Award – Dr. Rehan A. Kazi:-** Dr. Rehan A. Kazi has been awarded the prestigious 'British Journal of Surgery Prize' for his videofluoroscopy paper in Laryngectomy patients at the British Association of Surgical Oncology conference held on 28th November 2006, at the Royal College of Surgeons, London.

There were six candidates nominated for this British Award. All Six candidates – which included five Europeans Consultants – were asked to read out their papers. Dr. Rehan A. Kazi's paper was adjudged "The Best Paper" and was awarded "British Journal of Surgery Prize".

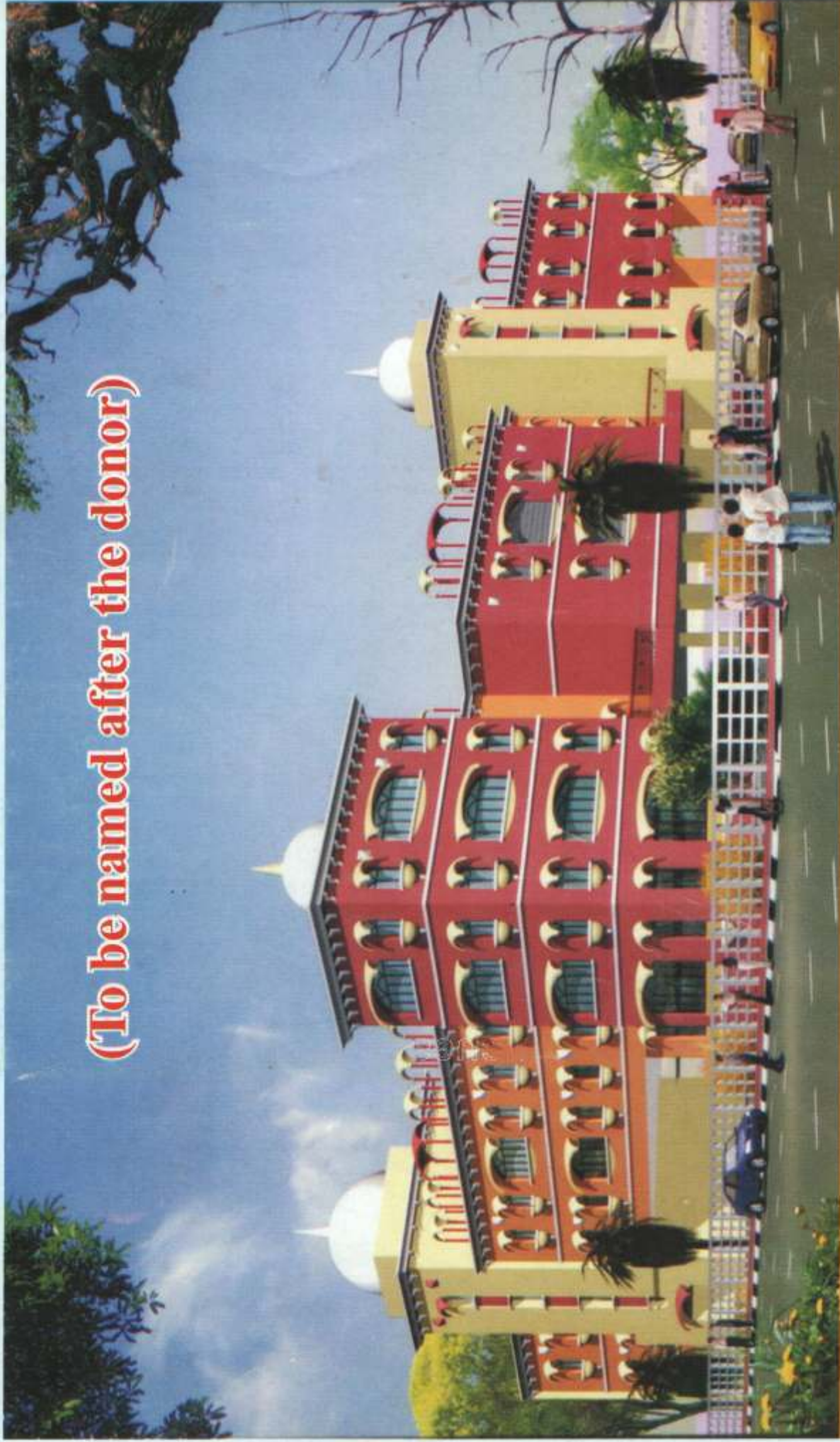
