ANNUAL REPORT (1-4-2005 to 31-3-2006)

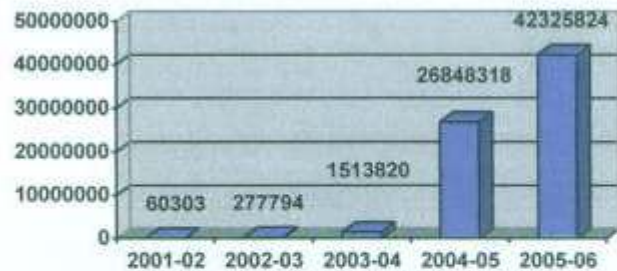
It is my great pleasure to present to you the annual report of the activities of the Cancer Aid & Research Foundation for the period ending 31st March 2006. The annual audit of the Foundation for the period ended on 31st March 2006 was completed in the month of June 2006. The following activities were undertaken during this period by the Foundation:-

1. **Audit:-** Our accounts for the period ended on 31st March 2006 have been audited by M/s. A.O. Bhamla & Co., Chartered Accountants, Mumbai – 400 003 and they have issued us the audit report to that effect.

The audit was very voluminous and was completed as per the schedule laid down by us. Henceforth, we are going to have a quarterly audit i.e. every 3 months.

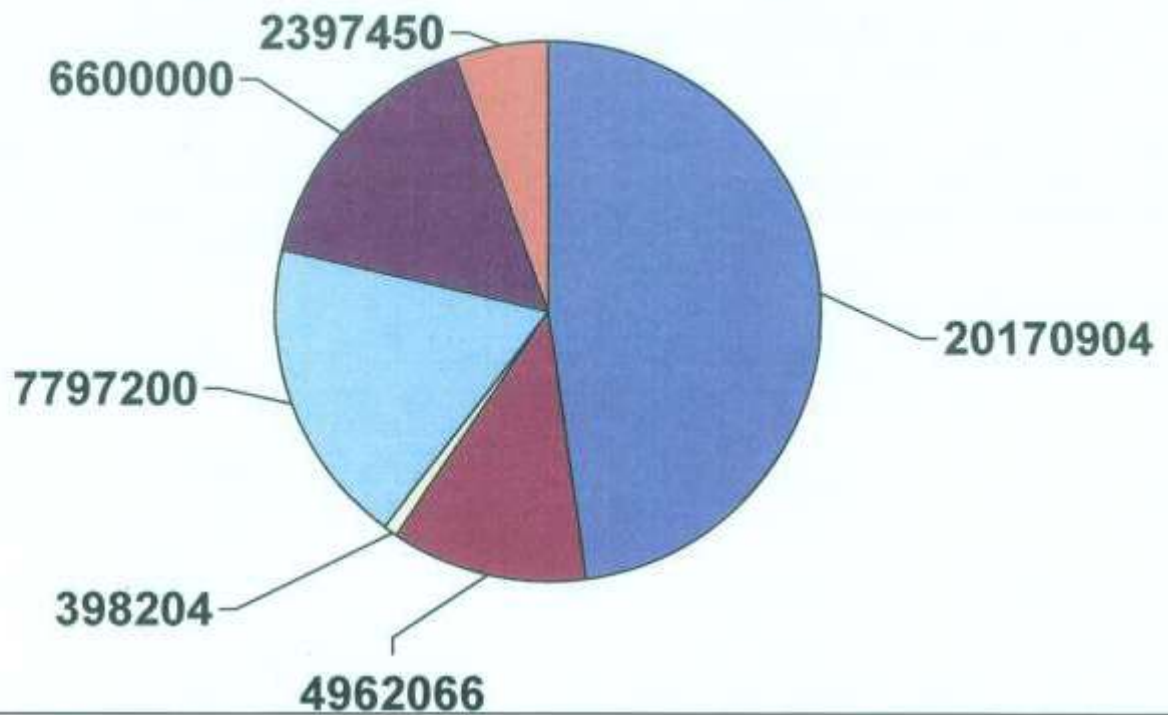
2. **Total Collections:** During the last four years immediately preceding the current year the total collections of the Foundation was as under:

BREAKUP OF TOTAL COLLECTION 2005-06

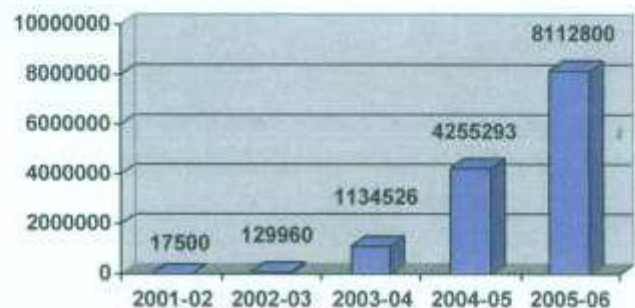

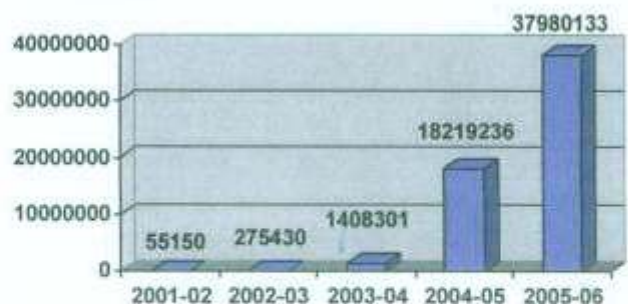
3. **Medical help to cancer patients:-** During this period we have helped 546 poor cancer patients covering about 74 hospitals all over India to the tune of Rs.81,12,800/-. This is almost twice the amount distributed in the preceding year. During the current year, we hope to help more than 600 patients with aggregate assistance in excess of Rs. 1 crore. The following table will give you a view of help provided to cancer patients during the last few years.

5. **Publication:-** We are publishing a quarterly CARF News Bulletin regularly. The bulletin goes to 25 countries of the world and it is appreciated by all. Mrs. Shaina Kara is the Sr. Editor. We also publish leaflets on cancer for educating the people and send them to all those who are on our mailing list. The idea of the publication is to create public awareness about cancer. For this purpose we also show films on cancer to the students of schools and institutions. After the show a collective pledge is taken from them that they will not smoke or eat gutkha, lime, tobacco, etc. This is a very important function of the Foundation as we feel 'Prevention is better than cure.'

6. **Collections:-**

I) **Schools:-** After showing the cancer films to students we also distribute the cards to the students for collection of donation. During the last year the students collected Rs.2,89,105/- as donation.

II) **Box Collection:-** We have so far placed more than 100 boxes in the departmental stores, Malls, big bazaars, 5 star hotels, etc. The response is good. During the last year we have collected Rs. 66,962/-

7. **Cancer Patients Hostel:-** According to a survey, 125 cancer patients come daily to Mumbai from all parts of India. However, there is no satisfactory hostel facility to house them. As a result most of them invariably are found on the footpaths around the hospital. We have therefore given top most priority to this project. We have now acquired 2 acres of land at Sheel Phata, near Kausa – Thane at the cost of Rs. 90 lakhs. The foundation stone of the cancer patient hostel will be laid by the end of September 2006 and we hope to complete the construction work by the beginning of next monsoon.



8. **Foundation Day:-** The Foundation, for the first time since its inception, celebrated "Foundation Day" on 20th June 2005. The celebration – Variety Entertainment Programme by Zeba Orchestra – was held at Y. B. Chavan Pratishthan Hall, Gen. J. Bhosle Marg, Near Mantralaya, Mumbai – 400 021. The Guests of Honour were Hon. Shri. Dilip Valse Patil, Minister for Higher Education, and Hon. Shri. Arun Gujarati, Ex. Speaker and President, (NCP) Maharashtra. The celebration was extremely successful.

On this occasion a souvenir was also taken out to meet the expenses of the celebration. About 150 cancer patients also attended this function. They were given food packets and a clock.

9. **Amendments to the Trust Deed:-** The Trust Deed of the Foundation needed amendments in the light of its activities and new responsibilities. I am happy to inform you that the Charity Commissioner has approved the New Scheme of the Trust Deed of the Foundation on 29/11/2006.

Kazi, MBBS. She is available in our office from 10.00 a.m to 11.00 a.m. She gives counselling to the cancer patients pertaining to all their questions, beliefs and fears about this dreaded disease of cancer. I hope the cancer patients shall take maximum advantage of this facility.

13. **Eid – Diwali Get - Together:-** The Foundation, for the first time, organized a get together for Eid & Diwali. The gathering consisted of staff members, cancer patients & invitees. The function was held in the Hall and there was a mimicry programme also. On this occasion the cancer patients were given gifts & lunch. The function was attended by Dr. Ishaq Jamkhanawala, President, Anjuman – I –Islam, Mr. H. M. Dalwai – Patron of our Foundation & Mr. Aslam Patel – Dy. Engineer – The BEST Undertaking.
14. **Greeting Cards:-** For the first time, we printed greeting cards of Eid, Diwali & New Year. About 2000 Eid cards were sent to our donors & well-wishers. The idea was not only to extend Eid Greetings but also to create goodwill for the Foundation. From the reports reaching here, the cards have been well received by the people.
15. **Press Secretary to the President of India:-** Mr. S. M. Khan, the Press Secretary to the President of India, visited the Foundation on Monday, 21st November 2005 at 5.00 p.m. along with his wife. His visit was in response to our earlier invitation to His Excellency, Dr. A. P. J. Abdul Kalam to visit the Foundation. The function was a grand success and it was attended by Dr. Ishaq Jamkhanawala, Mr. Farooque Darvesh, Mr. Ali M. Shamsi, Mr. Imran Furniturewala & Trustees. Speaking on this occasion Mr. S. M. Khan not only praised the activities of the Foundation but also announced several times that he would ensure the visit of the President of India to the Office of the Foundation. We are therefore looking forward for His Excellency to visit in next 2 to 3 months. In this function, he also handed over Foundation cheques and gifts to 6 cancer patients amounting to Rs. 6,05,000/-The function was also well covered by T.V. channels and Print Media.



16. **Talk on 'Voice Restoration after Laryngectomy':-** The Foundation had arranged a special visit by Mr. Peter Rhys Evans, Head of Head & Neck Cancer Unit, Royal Marsden Hospital, London to Mumbai. On this occasion he visited the Foundation office in the morning and thereafter gave a talk on "Voice Restoration after Laryngectomy" at West End Hotel, Mumbai. During his visit to the Foundation office he was taken around the various departments of the Foundation. He was so impressed by the

activities of the Foundation that he even suggested bilateral co-operation between the Foundation and the Institute of Cancer, London. Many Oncologists, doctors and prominent persons attended this lecture.



17. **Ambulance:-** Ms. Farzana Contractor, CEO, Afternoon Despatch & Courier Services, Mumbai donated an ambulance for taking cancer and other patients to the hospitals. On 13th October 2005 she visited the Foundation and handed over keys of the ambulance to the Chairman. Speaking on this occasion, she complimented the Foundation for its activities and also hoped that the ambulance will be helpful for the patients. On this occasion she also handed over our Foundation cheques to 5 cancer patients amounting to Rs. 4,35,000/.



18. **Cancer Detection Camp:** Cancer Aid & Research Foundation held a free Cancer Detection Camp for women on 12th March 2006 at Kazi Clinic, Mazgaon, Mumbai – 400 010. The response was immense. Free breast cancer detection, gynaec check-up, counseling and Pap smear test for cervical cancer were done. We hope to have more such cancer camps in next year. Dr. Bineeta Mehta and Dr. Asra I. Kazi helped in making this camp a success.



19. **Fellowships:** As a result of the visit of Mr. Peter Rhys Evans, Head, Head & Neck Cancer Unit, Royal Marsden Hospital, London, U.K. it was decided that the Royal Marsden Hospital would recruit Research Fellows through our Foundation vide their letter dated 11th October, 2005. In pursuance of this we had advertised the research post for streams as under:

- a. ENT/Head & Neck Surgery
- b. Radiation & Oncology
- c. Molecular Biology

Accordingly, the candidates have been chosen and our list was sent to the hospital.

20. **ISO 9000:2001 Certification:** I am happy to inform you that we have been granted ISO 9000:2001 certification for being a medical NGO. This Certificate is valid upto 16th January 2009.



21. **35AC Notification:** We have applied for 35AC Notification to the Secretary, National committee for promotion of social and economic welfare, Ministry of Finance, New Delhi on 2nd January 2006. We have started receiving inquiries from donors about 35 AC Notification. If we obtain this certificate we can generate more funds from donors and well wishers, which would help us to pursue our project of Rs.155 crores to construct Cancer Hostel, Hospital, Diagnostic Centre and Hospice.
22. **Membership of ICISG:-** I am please to inform you that we have been accepted as an 'Associate Member' of the Board of ICISG (International Information Services Group) Toronto, Canada in November 2005.
23. **Life Time Achievement Award:** Our Chairman Prof. A. A. Kazi, has been awarded 'Life Time Achievement' award by the Life Care Foundation, Mumbai for his dedicated services in the field of education and health.
24. **Funds for small scale project at the German Consulate:-** Cancer Aid & Research foundation had approached German Consulate for donation in response to which, they had sent us a questionnaire to be filled by us. The maximum grant provided in it in a year is Rs. 4,50,000/- Accordingly Cancer Aid & Research Foundation would be using this vehicle for carrying cancer patients from the place of their accommodation to the Tata Memorial Hospital or any other hospital, where they are undergoing treatment. The cost of this 32 mini seater mini Tata bus is Rs. 9,49,722/- out of which Rs. 4,50,000/- shall be donated by German Consulate if they approve our project and balance amount shall be incurred by Cancer Aid & Research Foundation.

These are the developments in nutshell. I request you to give me your suggestions for the improvement of the work of the Foundation. Last but not the least, I thank all of you for your co-operation without which the foundation would not have done so much in such a short time.
